



Terms & Conditions of Hire

1. Fittings

- 1.1 Fittings only per appointment as to ensure quality attention to enquiries and fitting.
- 1.2 In the event you should choose not to purchase Brogues or a Jacobite shirt, please bring your chosen shoes and shirt for the event along to be able to view the completed set.
- 1.3 Fitting times are:
 - Monday & Tuesday: 8h00-16h00
 - Thursday & Friday: 8h00-16h00
 - Saturday: Per request
- 1.4 Please ensure fitting occurs 3 working days before the required rental date to ensure that necessary alterations can occur if required.
- 1.5 In the event that a fitting cannot occur, or sets are ordered telephonically or by e-mail Blair Atholl Kilt Hire & Outfitting cannot be held responsible if there is any discrepancy or direct size mismatch on the client's side.
- 1.6 The courier of hired goods is for the client's account. Notably when hired goods are couriered back to Blair Atholl Kilt Hire & Outfitting the punctual and prompt return of hired goods still applies as well as the R200 late fee per day.

2. The integrity of the hired set

- 2.1 No alterations whatsoever are permitted to be made to any part of the rented set this includes: The kilt or any part thereof, the Prince Charlie Jacket or any part thereof, belt, bowtie, sock flashes or kilt pin.
- 2.2 Blair Atholl Kilt Hire & Outfitting will personally hold the renter liable for any part of the hired set not returned or liable for required repairs or special cleaning if required.
- 2.3 The complete hired set is required to be returned on the date agreed upon before 12h00. A fee of R200 will be charged per day for late returns.
- 2.4 The necessary under-garments will always be worn. The failure to respect this will result in a R2500 specialized cleaning fee.
- 2.5 No hired set belonging to Blair Atholl Kilt Hire & Outfitting may be washed, ironed, rinsed, dry-cleaned in any way or form without written permission.

3. Hiring a kilt set

- 3.1 The original Identification book/card as well as proof of address of the person renting a kilt set will be required.
- 3.2 A 50% deposit will be required upon renting a kilt set with the full amount to be paid upon the return of the kilt set.

- 3.3 In the event that a kilt set is booked for hire for a client/s for a specific date and the event is cancelled the renter will forfeit the 50% deposit. If the hire of kilt set/s is paid in full and cancelled within 7 days of the hired date the whole cost is forfeit. Special circumstances will be considered.
- 3.4 As traditional tartan kilts represent family's names as well as heritage, it is expected of any and all who dress in another family's tartan to behave themselves in a courteous, respectable and civilized manner.
- 3.5 The required undergarments will always be worn, any failure to do so will incur a specialized cleaning fee of R2500. This point is non-negotiable and will be enforced with the utmost of strictness.
- 3.6 A valid credit card will be required to be scanned into the system to where charges will be directed in the failure of the renter as to return the rented good in a timely manner or if goods are not returned in the same condition as when it left Blair Atholl premises or if in fact finally the return of rented good does not occur.
